**New Entrant Waitlist Notice**

The BC Turkey Marketing Board is now accepting applications for vacancies that have become available on the New Entrant wait list.

Vacancies will be filled from eligible applicants who have submitted their applications for consideration on a waitlist where there is a vacancy. The Board will randomly draw the required amount of applicants for the waitlists.

The Board will post for **90 days** on their website (in the News & Events section) a notice informing potential applicants the date upon which a draw will occur. Waitlist invitees will be placed on a waitlist in the order in which their names were drawn.

**There are vacancies in the following priorities:**

Priority 1	New Entrant Applications for Organic Turkey providing there is a market demand
Priority 2	New Entrant Applications for growing turkeys and selling turkeys in Regional Markets outside the Lower Fraser Valley
Priority 3	New Entrant Applications to produce Commercial Turkey anywhere in BC.

**1.No person who owns or has previously held quota in one of the SM5 sectors (milk, eggs, turkey, chicken, broiler hatching eggs) is eligible to apply for or receive new entrant quota.**

That for the purposes of the above requirement:

- a. "person" included that person in their own name, any partnership in which that person is or was a partner, or any company or limited partnership in which that person holds or has held shares; and
- b. "person" includes spouse. A spousal relationship is a relationship in which persons (i) are married or (ii) are cohabiting in a conjugal relationship, having so cohabited for a continuous period of at least one year.

**2.To be eligible to be added to the waitlist, every applicant is required to file with the Board a sworn or notarized document (a-g):**

- a. Making full disclosure with regard to Items 1a and 1b above and undertaking that the applicant will promptly notify the Board of any new information or developments pertaining to required disclosures at any time while the person remains on the waiting list.
- b. Undertaking that the applicant understands and is prepared to comply with all the requirements of the new entrant program as they exist from time to time, including the requirement to operate any quota granted under the program as an independent production unit, and be involved in the day-to-day operations of the farm.
- c. Confirming that all the rights and privileges subsequently obtained under the new entrant program including quota subsequently granted, may be revoked without compensation if it is determined that the applicant(s) has provided false or misleading information, or has failed to comply with the conditions or requirements of the program.
- d. Confirming that the applicant understands and agrees to the publication of that person's name on the waitlist, or that person's name as a successful applicant, as required by participation in the new entrant program.
- e. Only persons being residents of British Columbia over the age of 19 years and who currently own land suitable for raising turkeys shall be eligible to apply as a new entry grower.
- f. New entry growers, whether producing certified organic products, serving local or regional markets by direct marketing, or supplying the commercial market through processors or turkey brokers, shall be obligated to comply with the provisions of the Board's General Order and Regulations.
- g. Understand that New Entrant Grower Quota may be held for production only for so long as the entrant continues to engage in production in a manner consistent with the Turkey Board's selection priorities (specified in section 54 of the Board's Order and Regulations).
